Texas A&M University HPRC Summer Computing Academy Rules and Code of Conduct

Guiding Principles

- To ensure that the rights of all individuals are protected while attending this program.
- To establish the safest and best possible learning environment for all program participants.
- To ensure that breaches of the rules and code of conduct are treated in a fair and consistent manner.

Behavioral Expectations

- All parents and participants have the responsibility to treat one another, counselors, and property with respect.
- All parents and participants have the responsibility to act and behave in a way which does not endanger, intimidate, or interfere with the participation of others.
- Participants have the responsibility to follow the instructions given by the program counselors.
- All parents and participants have the responsibility to behave according to the *Aggie Code of Honor*, "An Aggie does not lie, cheat or steal or tolerate those who do."
- All parents and participants have the responsibility to behave according to this code of conduct.

Expectations for Attire

- Participants are required to wear appropriate clothing that is not distracting to other participants.
- Clothing should cover the body and should fit in such a manner as to promote the modesty of individuals
 and shall be in reasonable conformity with contemporary community standards for the age group
 involved.
- Clothing may NOT contain offensive, obscene, vulgar, or suggestive pictures or slogans.
- Participants are required to wear closed-toed shoes at all times.

Further Expectations

• To protect other participants from contagious illnesses, participants infected with certain diseases are not allowed to come to this program while contagious. If a parent suspects that his or her child has a contagious disease, the parent should contact Texas A&M HPRC so that other students who might have been exposed to the disease can be alerted.

Rules

The following forms of behavior are considered a violation of this document and are unacceptable and could result in the immediate dismissal of the participant(s):

- Horseplay or other disruptive behavior.
- Fighting, bullying, or any other forms of aggressive behavior
- Using language which is offensive, sexist, or racist..
- Leaving the program area without permission.
- Behaving in a manner which is potentially dangerous to self and others.
- Behaving in a manner which damages or vandalizes the property of others or the Texas A&M University campus.

• Bringing cigarettes or any tobacco products, alcohol, non-prescribed drugs, weapons, and/or explicit or inappropriate material to this program.

Any breach of the Rules or the Code of Conduct will initiate a disciplinary action. Texas A&M University High Performance Research Computing reserves the right to suspend or dismiss a student's participation in Summer Computing Academy activities, without refund of academy fees, if such disciplinary action is required.
